

# CSR Initiative - 1 & 2 @ Jamshedpur (Health Camp & Mid-day Meal for girl students)



Objective—

Upliftment of tribal community by giving them adequate healthcare facilities & give mid day meals to girl students of Lakhadia School. (Started in Oct 2004)

**Activity** 



In the villages of Bhagabandi and Badalgoda of [Dumaria Block], interior of Jharkhand (naxal dominated area), RSB conducts free medical camps once a month. In addition, every month provisions are supplied to School girl studets for mid-day meal. Blankets have been distributed to girl students in Winter of 2019 to protect them from severe cold.

Social Impact Assessment

Company physician & representatives visit these places to provide free medical check-ups, consultancy and medicines to the villagers. Distributed winter blankets to girl students in winter of 2019.



Till date almost 50,000+ patients have been treated so far. Good recovery. Non-invasive treatment. Due to counselling, healthy eating and living habits inculcated. Better standard of living Patients are extremely satisfied with the treatment. Chronic cases are referred to hospitals. Total 56 students benefitted from mid-day meal.

In Joy of Giving Week, distributed Fruits/gifts to registered pregnant women having MCTS (Mother Child Track System) card at village Anganwadi Centre for promoting "Early registration". . Sanitary Napkin to adolescent girls staying at rural road-side transit huts. Distributed mosquito nets for preventing Malaria & Dengue to deep rural underprivileged around Lucknow.

- Regular payment of monthly fees to under-privileged & BPL students totalling to 24 students, after verification of documented credentials
- Monitor & Check their improvement in academic performance
- Interact with teachers and principal for their academic improvement where gaps are noticed
- Interact with their parents how they work at home for studies and take their feedback.
- Distributed Sanitary Napkins to adolescent girls & mosquito nets to road-side hutment dwellers.

- Free medical assistance/Consultation

- 24/7 assistance
- Treatment at site where patients cannot reach clinic
- Reaching patients to nearby hospital for critical cases after giving emergency aids in mobile clinic
- Every patient given Health History Card for proactive track of chronology of illness with vital health parameters recorded
- Saving scores of lives with timely medical help
- Surgical treatment in emergency cases
- Preventive health check-up of under-privileged students.
  - Two doctors & one Para-Medical Staff maintain Health Centre. Dr BK Sahoo, MD(Pediatric), FIAMS(Pediatrics) and Dr BC Marandi, MBBS & 2 drivers to take care of emergency.
- Expansion work completed 1000 sq ft to house Dr Examination Room, Medicine Store Room and Dr's Cabin. Electricity & misc work pending

## Social Impact Assessment

- Total of 4390 patients(monthly average of 366) Apr 19-Mar 20 were attended at Health Centre during the year, who were examined, medical advice provided and medicines administered free of cost
- Total 124 under-privileged students were medically examined free-of-cost
- Total of 103 cases were given minor surgical treatment, stitching/ dressing(Apr19-Mar20)
- Total of 116 serious patients were sent to different referral hospitals at Tangi and due to their critical nature of illness thro' RSB Mobile Clinic free of cost.(Apr19-Mar 20)
- Every patient issued with Health History Card to keep track of chronology of illness with vital health parameters recorded during every check-up
- Ambulance travelled total distance of 9860 kms during the period ferrying serious and emergency cases. Mobile Medical Unit travelled total distance of 142 kms carrying highly critical cases to admit patients at SCB MCH & CHC, Tangi.
- Ambulance maintained with dedicated drivers devoid of breakdown.
- Expansion work of 1000 sq ft for two doctors'c abin, examination room and medical store room well in progress.

- Girl students excelling well in studies
- Attendance more than 90% and absenteeism mainly due to normal health reasons on account of seasonal climatic changes
- Medical check up done and reports given to Parents, who are advised to take care where issues are noticed by the certified doctor (qualified MD Pediatrics).
- Indian values/culture well taught and noticed in practice.
- Green ambience and surrounding.



Women trained on Mental Health Issues and ill-effects of Addictions by doctors and para-medical staff. 110 selected Women will go through intense Leadership Development Program and will be the peer leaders for various change initiatives in their respective localities. 250 Daughter-inlaws, coming in the project areas, will be imparted knowledge on Reproductive Health, Better Relationships with families and capacity to cope up with the changed environment.

Total of 4010 slum women were trained in various skills, viz Treatment of Anaemia through camps, Leadershipk Programs, Newly Weds Counselling, Mother-inn-law & daughter-in law counselling Meets, Mental Health Groups, Skill Development for sustenance
